REGISTRATION POLICIES

PLEASE READ THE FOLLOWING CAREFULLY:

METHOD OF PAYMENT: Prior to June 15th, each application must be accompanied by a minimum of 50% of each student's total registration fee. Balance of payment is due by June 15th in order to guarantee student placement and week selection. **Liberty will automatically debit your credit card should payment not be made by this date.** Applications received after June 15th must be accompanied by payment in full for the TOTAL registration fee. Payments received that are not negotiable will be subject to a \$35.00 service charge.

ACKNOWLEDGEMENT: LU-CHS will acknowledge receipt of your application with an acceptance, suggested alternative letter or email, depending on current program's enrollment. All of our programs are offered on a first-come, first-served basis. There is no reduction in fees for late arrivals or early departures. Liberty strongly suggests that you send your application as soon as possible to ensure your program participation.

PROGRAM CANCELLATION: No monies deposited are refundable in the event of student cancellation or termination unless **cancellation insurance** has been purchased.

CONDITIONS OF ENROLLMENT: LU-CHS reserves the right to move students if they feel their choice of programs are not within the evaluation guidelines dictated. This program adjustment is made with the student's best interest in mind. Liberty also retains the right to terminate the stay of any student, when it is deemed to be in the best interest of either the student or the school. Group composition is subject to final enrollment numbers and as such, students may be combined if registration totals don't warrant full program figures.

LATE PAYMENTS/WALK-UP REGISTRATIONS: Students will not be allowed on the ice without final fee payment. Walk-up registrations are discouraged, but in some circumstances allowed, due to the necessity of planning and organization of the Hockey School. Full payment will be required in such circumstances.

Agreement and Assumption of Risks: By voluntarily participating in the sport of ice hockey and ice skating, I and/or my child hereby knowingly assume(s) the risk of any injury or harm associated with such activity. I acknowledge and agree that ice hockey is a contact sport and, as such, constitutes an inherently dangerous activity involving a significant risk of injury or death including, but not limited to, being injured by physical contact with other players, being hit by the puck, and slipping and falling on the ice. I hereby agree that Liberty University Christian Hockey School (the "School"), its agents, servants, and employees shall not be made liable to me and/or my child for any injury or damage resulting from my and/or my child's participation in ice skating and ice hockey, whether incurred on the ice or otherwise in or about the buildings at any time preceding, during or subsequent to the delivery of the instructional program based on any risk that I or my child assumes hereby. I hereby agree to indemnify, defend and hold the School harmless from any and all loss, claim, expense (including attorneys' fees), and cause of action brought by any person or entity (including my child) by reason of injury to person or damage to property arising out of my and/or my child's use of the School's facilities.

I acknowledge and agree that no portion of my and/or my child's registration fee will be refunded to me and/or my child in the event, for whatever reason, I and/or my child withdraws from the School's instructional program. Further, I acknowledge and agree that no portion of my and/or my child's registration fee will be refunded to me and/or my child in the event of cancellation of the program for reasons beyond the School's control, including cancellation of ice time, damage to plant or buildings, mechanical breakdown, acts of God or other failure of the facilities which would, in the School's sole and unfettered discretion, prevent the proper operation of the instructional program. I acknowledge and agree that the School does not insure and will not be expected at any time to insure, the safety or the proper state of repair of my and/or my child's equipment used by me and/or my child during the instructional program, and that the School does not and shall not be considered to guarantee or warrant the instructional materials used by it during the instructional program. I acknowledge and agree that the School reserves the sole and exclusive right to use any photographs taken during the instructional school for advertising and/or instructional purposes, without cost or charge whatsoever to the School.

I understand and agree that the acknowledgements, agreements, and assumption of risk provisions contained herein shall bind my heirs, legal representatives and assigns and shall inure to the benefit of the School, its agents, servants and employees and their successors and assigns.
