



# Why We Do What We Do

**Almost 21 million Americans have at least one addiction, yet only 10% of them receive treatment. (328.2 m)**

Every year, worldwide, alcohol is the cause of deaths of 1 in every 20 people.

More than 90% of people who have an addiction started to drink alcohol or use drugs before they were 18.

- Approximately 2.1 million Americans have an opioid use disorder.
- About 494,000 Americans over the age of 12 are regular heroin users.
- About 30-40 million Americans smoke marijuana every year.
- About 30% of people who regularly use marijuana have a cannabis use disorder.
- About 964,000 Americans are addicted to meth.
- About 5 million Americans are regular cocaine users.
- About 88,000 people die as a result of alcohol every year in the United States.
- Over 15,000 Americans died from a heroin overdose in 2017.
- About 130 Americans die every day from an opioid overdose.
- About 10,000 die each year from crystal meth.

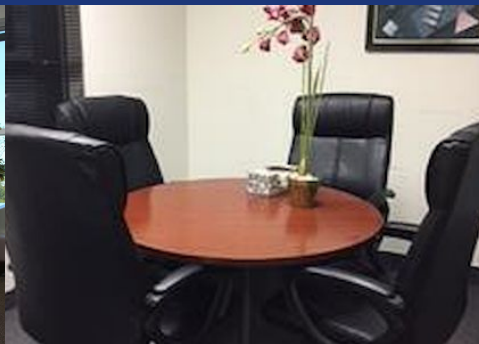

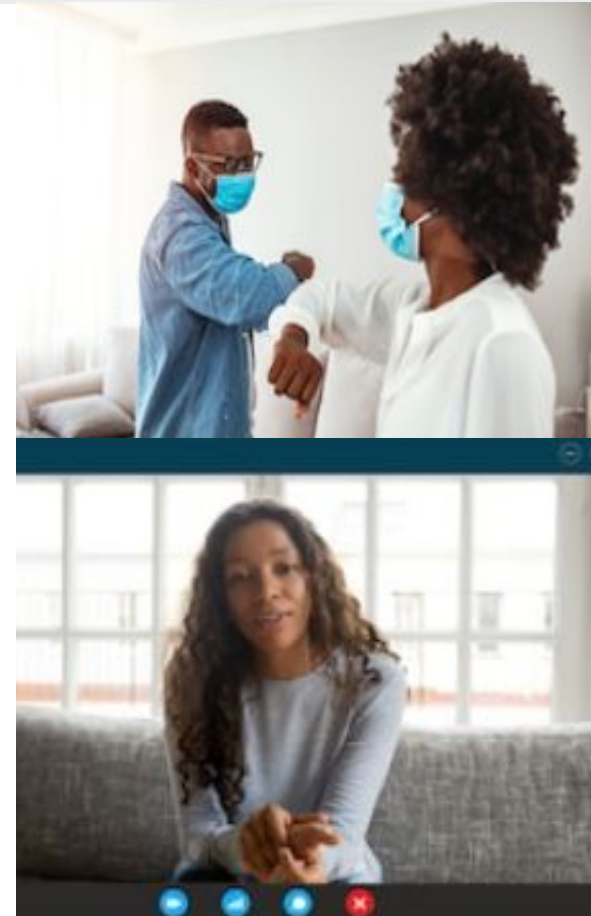

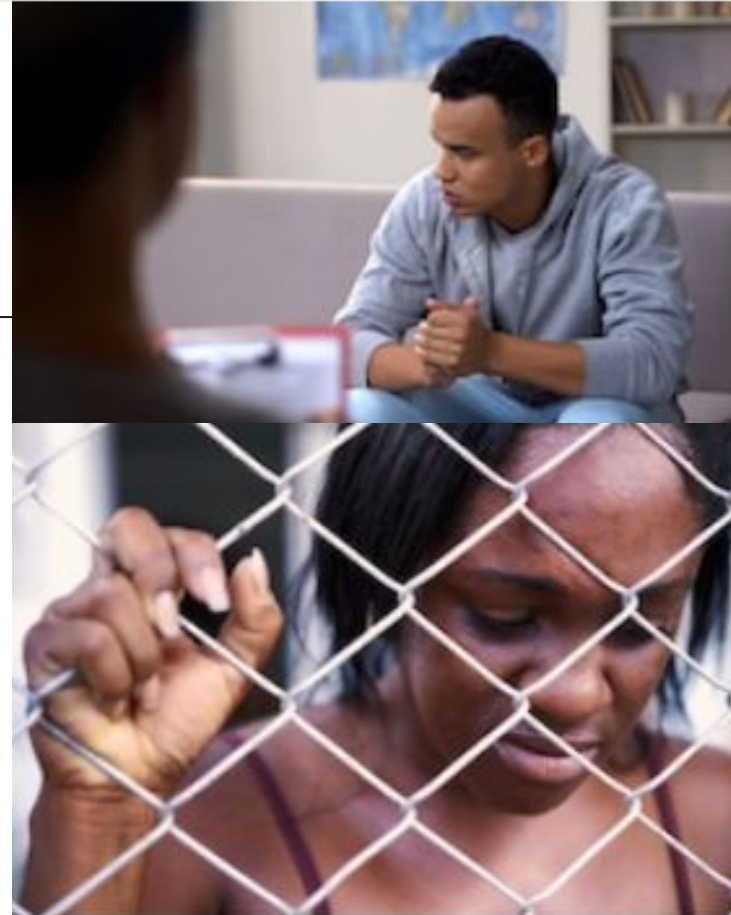

# Trauma Informed Addiction Treatment

---

- Assessment and counseling approach to support the unique needs of those who have experienced trauma.
- Treatment model dedicated to safe relief from trauma related triggers and identification of undiagnosed disorders.
- Referral for medication assistance for symptoms of PTSD
- Relapse Prevention Skills Development as new positive coping mechanisms.



# Substance Abuse Education & Treatment for Families

---

- Counseling for collateral trauma brought on through care or exposure to a loved one with a substance use disorder.
- Psychoeducation about the disease of addiction and methods to support recovery efforts.
- Family reunification counseling
- Couple's Sobriety Training
- Anger Management and Conflict Resolution Training
- Supportive response for court appointed family reunification



# Addiction Recovery Support for Violent Offenders

---

- Assessment and counseling dedicated to the reclamation of balanced life for those convicted or at fault for a violent act due to substance abuse intoxication.
- Treatment dedicated to healing from guilt & shame related to ongoing violent behaviors related to substance use.
- Education about the “addict brain” and the impacts it has on behavior, decision making and responsiveness.
- “Redemptive” therapy approach to support forgiveness, amends and abstinence from further events of violence.



# Court Appointed Family Reunification Mandates

---

- Assessment and treatment for parents who lost custody or visitation with children due to the effects of a substance use disorder.
- Collaborative reporting and monitoring to ensure treatment progress in meeting the terms of court orders.
- Family education and counseling as a condition of treatment planning - prior to program completion.
- Case management assistance for non treatment related terms such as employment, housing and medication compliance.



# Employee Assistance Program

---

- Assessment and treatment for employees who have been identified through employer drug testing, post accident/incident or due to self referral.
- Collaborative reporting and monitoring to ensure treatment progress in meeting the terms of return to work agreements.
- Coordination with the Department of Transportation staff to reinstate driving privileges for work purposes.
- Continuum of care services post intensive treatment to ensure ongoing maintenance of treatment program up to a year following initial referral or work related incident.
- Coordination with short & long-term insurance carriers where applicable to assist with cost of employment separation.

- **Assessment and full service treatment**
- **Referral and support for other support services**
- **Community education and 12 Step Support Meetings**
- **Translation services for community partners**

## Receipt of Referral from Community Partner

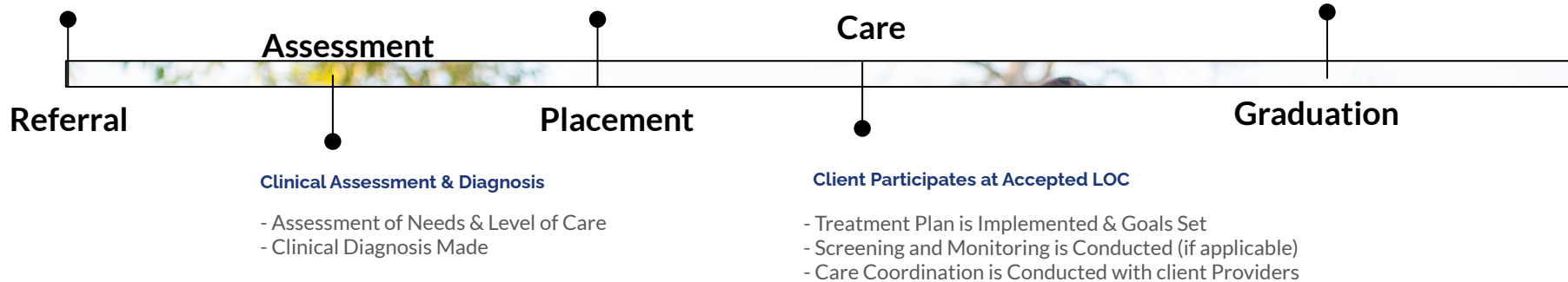
- Online Intake Form & Appointment
- Phone Intake & Screening
- Email Correspondence
- Other process developed by vendor

## ASAM Level Of Care Recommendation

- Client is placed in PHP, IOP or Outpatient
- Client accepts or denies placement recommendation
- New recommendation is made if possible

## Client Successfully Completes the Program

- Client receives certificate of completion
- Graduation Ceremony is conducted
- After Care Plan is Initiated
