The Advanced Internship Assessment (AIA) is used during the final internship course for advanced licensure candidates to assess their performance on using the standards of their area of specialization in a school setting.

- f. Application of professional dispositions, laws and policies, codes of ethics and professional standards appropriate to their field of specialization

Analysis of data results:

All candidates in three out of the four advanced licensure programs meet the benchmark (level 2) or higher for all six professional skills from CAEP on their final internship capstone project. Ninety-nine percent of candidates in the school counseling program also met benchmark or higher in these same six professional skills.
