

LUCOM Master Affiliations Listing

LUCOM requires an affiliation agreement be in place prior to the student starting a rotation. An Affiliation Agreement Request Form **must** be submitted to LUCOMAffiliations@liberty.edu for each new request, *preferably 4-6 months prior to the rotation start date.*

Expiration Dates

- Sites marked with an asterisk (*) do not expire.
- If the agreement for a site has an expiration date, the date is noted.

HCA Healthcare / ClinicianNexus

- LU and HCA have an agreed-upon template for rotations. HCA rotations must be processed through the ClinicianNexus online portal. They will generate the agreement once the student doctor has accepted the rotation with HCA. **Student doctors do not need to submit an affiliation request** for HCA hospitals when working through ClinicianNexus, as they will contact LUCOMAffiliations.

VSLO

- Institutions that use VSLO typically do not require an affiliation agreement. However, there are some sites that may still require that an affiliation agreement be in place prior to the student starting an elective. If a site requires an agreement with us, they will reach out to LUCOM once the student has been accepted.
- There are some VSLO institutions that are on the “Can’t Come to Terms” list. We strongly recommend you review the “Can’t Come to Terms” list for the state the institution is located in.

WellSpan York

- Once students are accepted into their rotation with WellSpan York, the rotation coordinator will reach out to LUCOM with the agreement template. **No request form is needed.**

Sites with Additional Rotation Fees

- Per LUCOM policy, you as a student-doctor are responsible for all fees associated with clinical rotations that occur away from the Core Rotation sites. If an away site requires that an administrative fee be paid by the COM, the student will pay this additional cost to the COM, who will then arrange to send payment to that specific site. LUCOM will cover the first \$100 of this cost.
