2.5 GPA

No grade of D or below may be applied to the degree (includes grades of D+ & D-) Liberty University course work that is more than ten years old may not be applied towards this degree. Students are required to repeat the course if it has exceeded the limit

Degree must be completed within 5 years

Submission of Graduation Application must be completed within the last semester of a student's anticipated graduation date
