COURSE SYLLABUS

PLST 340

FAMILY LAW

COURSE DESCRIPTION

This course provides a balanced introduction to the theories, doctrines, and practice of family law. Students will learn the fundamental principles of family law, discuss important policy issues, learn practical skills and consider the ethical issues confronted by those who help process legal documents in family law.

RATIONALE

With the downward shift in hiring patterns in traditional industries, many workers have decided to return to school and obtain a degree to pursue a new career. One recent news article reflected the demand for paralegals noting that some older students are exploring new career options. Some people come in and have gone to our paralegal program because the demand for paralegals is high. - I. Understand the basic legal requirements of drafting a premarital or marital agreement.

Two replies of 100–150 words each are due by 11:59 p.m. (ET) on Monday of Modules/Weeks 2, 4, and 6. Replies to Discussion Board Forum 4 are due by 11:59 p.m. (ET) on Friday of Module/Week 8.

D. Short Answer Homework Questions

During Module/Week 1, students will be assigned two homework questions that require short answers. Answers must be submitted by 11:59 p.m. (ET) on Monday of Module/Week 1.

E. Short Essays (3)

There will be three short essays that are to be 250-300 words. Each essay must be submitted by 11:59 p.m. (ET) on Monday of Modules/Weeks 2, 4, and 6.

F. Quizzes (2)

There will be three open-book/open-note quizzes containing 30 multiple choice and true/false questions. Students will be given 1 hour to complete each quiz by 11:59 p.m. (ET) on Monday of Modules/Weeks 3, 5, and 7. Quiz 1 will cover the course material from Modules/Weeks 1–3, Quiz 2 will cover the course material from Modules/Weeks 4 and 5, and Quiz 3 will cover the course material from Modules/Weeks 6 + 7.

G. Final Exam Essays

Students will answer three short essay questions for the final exam. The exam must be completed by 11:59 p.m. (ET) on Friday of Module/Week 8.
