Complete 57 hours

A minimum of 42 hours must be completed through Liberty University, not to include prior degree earned through Liberty

A maximum of 15 hours of transfer credit, including credit from a degree on the same level previously earned through Liberty, may be applied to the degree

No grades lower than a B- may be applied to the degree

Successful defense of Dissertation

Degree must be completed within 7 years

Submission of Degree Completion Application must be completed within the last semester of a student's anticipated graduation date
