Complete 60 hours

A minimum of 45 hours must be completed through Liberty University, not to include credits from a prior degree earned through Liberty University

A maximum of 15 hours of transfer credit, including credit from a degree on the same academic level previously earned through Liberty, may be applied to the degree 3.0 GPA

No grades lower than a B- may be applied to the degree

Liberty University course work that is more than 7 years old may not apply towards this degree. Students are required to repeat the course if it has exceeded the age limit. Successful completion of Comprehensive Exam
