

## Qualifications for Student Appeals Court Members

In order for a student to become a voting member of the Student Appeals Court he or she must:

- Maintain status as a full-time student at Liberty University, with the exception of graduating seniors who do not need more than twelve (12) credit hours for graduation.
- Completed one (1) semester at Liberty University.
- Maintain a cumulative GPA of at least 2.5
- Not accumulate more than ten (10) points during the semester of their nomination and each semester that they serve as a Student Appeals Court Member.
- Not have accumulated more than eighteen (18) points during any semester, within a year prior of nomination.
- Not be on any form of probation or suspension (disciplinary, academic, etc.).
- Be approved by the Office of Community Life.
